


"That's Me In The Crossings"

- 7 minute drive to HWY 3 (soon to be less with the construction of the new Metis Trail).






*100.2% Population growth in West Lethbridge from 1994 to 2012

- Located next to Lethbridge's two newest high schools and public library.








Site Plan

- Construction to begin Fall 2014 (Development permit application for October 2014).
- Condo Association to be formed Fall 2014. (Fees to be determined.)
- Completion of first units late spring/ early summer of 2015.
- 6 dedicated off-street parking spots per fourplex.


- Modern flat-roof design
